

## Limited Life Time Warranty

Huntington Brass warrants that the faucets purchased by the original consumer buyer will be free from *leak and drip* during normal use for as long as such an original buyer owns their home (the "warranty period" for home owners) and that all parts and finishes will be free from defects in material and workmanship. As for all other buyers (including buyers for commercial, industrial, business and public uses), Huntington Brass warrants that the faucet will be free from leak and drip for a period of 5 years from the date of the original purchase. Huntington Brass also warrants that faucets will be free from defects in finishes for polished brass for three years, Satin Nickel and special finishes for 10 years, and limited lifetime finish warranty for Chrome and all PVD finishes. Proof of purchase (original sales receipt) from the original consumer buyer must be made available to us for all warranty claims. During the warranty period, Huntington Brass' sole obligation shall be to replace, FREE OF CHARGE, any part which proves defective in material and/or workmanship under normal use. Replacement parts or repair kit can be obtained from your local dealer listed in the telephone directory or by writing to our corporate address listed below together with a copy of original receipt. All transportation charges must be PREPAID by the requesting customer. This warranty is limited in that it covers replacement of defective parts and finishes only.

This limited warranty provided by Huntington Brass *DOES NOT COVER*: Faucets, if in Huntington Brass' judgment, have been subjected to abuse, accident, modification, negligence, misuse, faulty installation and lack of reasonable care, and repair or service not contemplated by the documentation for the products; Labor charges for initial installation, installation and removal of the faucet for repair, services for repair and replacement and shipping cost; Operational adjustments covered in the manual and normal maintenance; Damages incurred in shipment, installation, from the use of bathroom cleaners, and or scrubbing materials, or due to an act of God.

To the maximum extent permitted by law, Huntington Brass will *NOT BE RESPONSIBLE* under any contract, negligence, strict liability or other legal or equitable theory for any loss of use of the product, inconvenience, injury, or damages of any character, whether direct, indirect, special, incidental or consequential relating to this product, the warranty provided hereunder, or arising out of any breach of this limited warranty, even if Huntington Brass has been advised of the possibility of such damages. The sole remedy for a breach of the foregoing limited warranty is replacement of the defective parts. The maximum liability of Huntington Brass under this warranty is limited to the purchase price of the faucet covered by the warranty. The foregoing express written warranties and remedies are exclusive and are in lieu of any other warranties or remedies, express, implied or statutory.

Except for the limited warranty specified herein, the faucet is provided "as-is" without any warranty of any kind whatsoever including, without limitation, any warranty of merchantability, fitness for a particular purpose and non-infringement. Except as expressly covered under the limited warranty provided herein, the entire risk as to the quality, selection and performance of the faucet is with the purchaser of the faucet. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights, which may vary from state to state. To get replacement parts/faucet repair kit, simply write to our office using address below and explain the defect and include proof of purchase and your name, address, area code and telephone number.
